On 18 December 2017, Suining Zhonghe (an indirect wholly-owned subsidiary of the Company) (as principal) entered into an EC Contracting Agreement and Purchasing Contract with Nanjing Zhonghe (an indirect non-wholly-owned subsidiary of the Company) (as contractor) and Jiangsu Zhongsheng (as supplier) respectively for the development of the Distributed Photovoltaic Generation Facilities with a capacity of 19MW in Suining, Xuzhou, Jiangsu Province of the PRC. The aggregate considerations of the EC Contracting Agreement and the Purchasing Contract are RMB25,318,435 (equivalent to approximately HK\$29,896,008) and RMB86,831,565 (equivalent to approximately HK\$102,530,712) respectively. It is expected that the Distributed Photovoltaic Generation Facilities will be on-grid on or before 30 December 2017 and the installation work shall be completed on or before 31 March 2018. Upon completion of the installation work, the Distributed Photovoltaic Generation Facilities shall be owned and operated by Suining Zhonghe.

Suining Zhonghe (as principal) agreed to engage Nanjing Zhonghe (as contractor) to provide engineering and construction services in relation to the development of the Distributed Photovoltaic Generation Facilities. It is expected that the Distributed Photovoltaic Generation Facilities will be on-grid on or before 30 December 2017 and the installation work will be completed on or before 31 March 2018.

# Consideration

The total consideration under the EC Contracting Agreement is RMB25,318,435 (equivalent to approximately HK\$29,896,008), which shall be settled in cash and will be funded by internal cash resources and/or the proceeds from the proposed open offer as announced by the Company on 23 November 2017 (the "**Open Offer**").

The total consideration under the EC Contracting Agreement was arrived at after arm's length negotiations between Suining Zhonghe and Nanjing Zhonghe after taking into account of: (a) the construction and installation cost of approximately RMB20,274,700 (equivalent to approximately HK\$23,940,366); and (b) the design consultation fee of RMB5,043,735 (equivalent to approximately HK\$5,955,642).

The procurement for the Equipment will be made in accordance with normal procurement procedures between Suining Zhonghe and Jiangsu Zhongsheng on an arm's length basis and on normal commercial terms with reference to the market price for similar types of Equipment.

# **REASONS FOR AND BENEFITS OF THE DEVELOPMENT OF THE DISTRIBUTED PHOTOVOLTAIC GENERATION FACILITIES**

The Group is principally engaged in new energy operations (such as provision of development, operation, engineering and construction and procurement services for solar energy plants) and finance leasing services in the PRC. In addition, the Group has been participating in other businesses such as (i) inspection, maintenance, repair, construction, installation and provision of expertise in such works for nuclear power plants; and (ii) subcontracting of overseas engineering and construction projects via its subsidiaries and associated companies.

The Group has started to build, maintain and operate its own solar photovoltaic plant in Taizhou, PRC since 2015. Taking into account the target growth of the national solar photovoltaic policy formulated by the Chinese Government for the years 2016 to 2020, the Group committed to enlarge its solar power generation segment by installing, possessing and operating rooftop distributed solar photovoltaic facilities in Jiangsu, PRC. It is expected that the completion of the installation of the Distributed Photovoltaic Generation Facilities and after the commencement of its power generation will enable the Group's solar power generation segment to generate additional revenue.

The Directors believe and consider that the development of the Distributed Photovoltaic Generation Facilities, the EC Contracting Agreement and the Purchasing Contract are on normal commercial terms, the terms are fair and reasonable and in the interests of the Company and its shareholders as a whole.

# INFORMATION ON NANJING ZHONGHE AND SUINING ZHONGHE

Nanjing Zhonghe is a company established in the PRC and an indirectly non-wholly owned subsidiary of the Company. As at the date of this announcement, Nanjing

Zhonghe is indirectly owned as to 96.18% by the Company and 3.82% by Triple Delight Limited, an Independent Third Party. Nanjing Zhonghe is principally engaged in new energy projects contracting, construction, installation, maintenance and supervision and engineering design and consultation, sale of project equipment and materials.

Suining Zhonghe is a company established in the PRC and an indirect wholly-owned subsidiary of the Company. It is principally engaged in solar power generation, solar power projects development, construction and operation and provision of engineering management services. The major assets of the Distributed Photovoltaic Generation Facilities will comprise the Equipment. As the Distributed Photovoltaic Generation Facilities have not yet been put into operation and accordingly, no book value, revenue or profits associated with the Distributed Photovoltaic Generation Facilities were recorded in the financial statements of Suining Zhonghe.

Jiangsu Zhongsheng is a company established in the PRC and an Independent Third Party. It is principally engaged in the research and development and trading of mechanical equipment, photovoltaic equipment, electricity equipment.
